Senior Thesis Research Group (ECON 5900)

Major Assignment 3: Rough Draft

This assignment is due on Wednesday, April 7 by midnight. You *must* submit your proposal in Microsoft Word format. Submit your paper by email to the course TA.

Remember: This is one of the major assignments that must be submitted on time. A late assignment will result in a reduction of your course grade by one letter grade; no exceptions. You must discuss any modifications to the due date with us well in advance.

Details

Your rough draft is intended to be a first version of the final paper for this course. Hence, it should adhere to the formatting guidelines laid out in the <u>Senior Thesis Handbook</u> (which are copied below). There is no specific requirement as to structure. However, you might consider having the following sections:

- Introduction
- Research Method
- Data
- Results
- Interpretation and Limitations
- Conclusion

As a general rule, it is a good idea to emulate the structure, style, and format of the academic articles you have been reading for reference.

Assessment and Peer Feedback

We will assess your thesis according to the rubric attached below. You may want to keep the rubric handy and, as you write, as whether your thesis touches on all of the rubric categories in a meaningful way. After you submit your rough draft, we will review it to see whether it adheres to basic formatting guidelines and is free of major errors. However, we **will not** be doing a complete evaluation of it with respect to the rubric, and you should not assume that our comments represent an exhaustive assessment of the rough draft.

You are strongly encouraged to get other people to read and comment on your thesis before you submit it to us.

Thesis Format

Citation Style

You will use the Turabian author-date style. The *Turabian Manual* is a recommended text for this course, but not a required one. You'll find a free online quick guide to the style here. Also, many of the databases you'll be using in Galileo to locate research articles have citation generators associated with them.

Title Page

This page is not numbered. Place the title about a third of the way down, centered on the page. Under the title, type "Prepared for" (followed by your faculty advisor's name), the course name, and the semester, then "Prepared by" (your name), followed by your UGA e-mail address and the date. See the sample title page below.

Abstract Page

The abstract is one paragraph no more than 150 words long. It includes the scope of the paper and its argument, and it occupies the second page by itself. The label "Abstract" should be centered above the paragraph. It is not a substitute for the introduction.

Text

This whole section should be a **maximum** of 20 pages (unless you are writing an Honors thesis). The recommended length is 15 pages.

Use 12-point Times New Roman font, and one-inch margins on all four sides. Create a right-hand header made up of a shortened version of your title and the page number. Do not leave single lines of paragraphs at page ends or beginnings. Repeat the entire title at the top of the first page of text; leave extra space between it and the first line of the text.

Your paper should be divided into sections and each section should have a descriptive title. Do not leave sections headings alone at the bottom of a page.

Tables and Figures

First, know the difference. Tables are rows and columns of data. Figures are pictures, either graphical representations of data or other visual images.

As a rule, all tables and figures should be your own. Don't cut and paste from other papers, even with proper attribution.

Introduce tables and figures before inserting or appending them.

• "Table 1 is a list of OEDC countries by GINI coefficient of income inequality."

Assign each table or figure a number and a name, centered, with the following format:

• "Figure 3: Healthcare Spending as a Percent of GDP"

Number tables separately from figures, e.g.: Table 1, Figure 1, Figure 2, etc.

Add a source line, left-aligned, below the table or figure with the following format:

• "Source: Bureau of Labor Statistics, www.bls.gov"

Do not include the source of the table/figure in the bibliography unless you cite the source elsewhere in text.

References

This list should be introduced with the heading "References," centered on the page. It should be formatted according to the <u>Turabian author-date style</u>. It should include only references cited in the paper.
